These published rates have been approved by Eyemouth Harbour Trustees, and the Trustees' interpretation is final.

All lengths of vessels to be taken from Certificate of Registration.

All Berthing Charges are for non-exclusive berths and are inclusive of use of Port Waste Reception Facilities

Berthing is as directed by Harbour Master and the Harbour Master's decision is final.

Berthing is subject to Terms and Conditions of Berthing.

Where seasonal berths are applied, summer shall be 1 April to 30 September and winter shall be 1 October to 31 March.

1. CHARGES FOR FISHING VESSELS

TABLE 1
FISHING LOCAL COMPOSITE RATES (INCLUDING CREEL) (SUBJECT TO VAT)

By agreement with Eyemouth Harbour Trust, locally owned, registered fishing vessels regularly engaged in fishing from and landing in Eyemouth Harbour, on prior application being made in writing to the Harbour Master, may be eligible for compounded arrangements as follows:

Notes applicable to local composite rates:

1. Eligibility for composite rates is assessed annually based on previous year's landings.
2. Where no track record exists at Eyemouth, Category B rates will apply.
3. Where owners operate more than one vessel, the total gross landings value will be taken in to account.
4. Owners/Skippers who fail to pay compounded charge within agreed terms and those not eligible for composite rates will be liable for appropriate charge in Table 2A.
5. The compounded charge herein shall cease to be applicable to any vessel in this class continuously occupying a berth at the Trust's quays for a period in excess of 30 days. Such vessels will then be classed as either visiting or laid up and will be liable to be charged appropriate rate in Table 2A or 2C below.
6. Marine Scotland declaration must be completed. If this condition is not met, a higher rate of 3.5% landings is applicable.

TABLE 2C
FISHING (LOCAL & VISITING) LAID UP DUES (SUBJECT TO VAT)

In certain circumstances, any vessel occupying a berth at the Trust's quays for a period in excess of 30 days and not landing any fish will be classed as laid up and will be liable to be charged as follows. Any vessel on laid up dues for a period exceeding 3 months will be subject to review and may result in daily rates being applied.

NOTES APPLICABLE TO ALL FISHING VESSELS whether local or visiting;

1. Berthing is subject to suitable arrangements being agreed in advance for collection of landing dues.
2. Marine Scotland declaration must be completed. If this condition is not met, a higher rate of 3.5% landings is applicable.
3. In cases where skippers sell directly to Merchants, liability to account for Landing Dues rests jointly and severally with the Skipper and Owner if the Merchant fails to account to the Trust for the Landing Dues.
4. All vessels must produce satisfactory evidence of Third Party Liability insurance upon request. Sight of Certificate of Registration may also be required.

COMMERCIAL CREEL VESSELS WILL PAY ANNUAL HARBOUR DUES AS FISHING VESSELS ABOVE.

ANY NON-COMMERCIAL VESSELS WILL BE CHARGED AS LEISURE RATES DETAILED IN TABLES 3 & 4 BELOW

BY PRIOR ARRANGEMENT, DISCRETIONARY ACCOMMODATION MAY BE AVAILABLE FOR SMALL BOATS, SUCH AS TENDERS, DINGHIES, INFLATABLES OR COLLAPSIBLE BOATS UP TO 5M LOA. THESE ARRANGEMENTS ARE SOLELY AT THE HARBOUR MASTER'S DISCRETION AND ARE CHARGED AT £200 PER SEASON.

Notes applicable to storage of goods:

1. All goods and ships equipment, including trawl doors, nets, ropes, drums, lobster / crab, prawn pots and fish boxes to be stored on the quay only with the permission of, and directed by the Harbour Master.
2. All goods must be clearly marked with vessel's name and/or registration number.
3. Goods stored without permission will be charged a penalty.
4. Goods stored without authorisation will be disposed of after 14 days.
5. The Trust will not be responsible for the safe custody of any goods landed, deposited or stored upon any of their quays, wharfs, or premises; nor will they accept any liability for any loss (whether partial or total) or damage, however arising, which may happen to such goods.
6. As the Trust have no charge or custody of goods landed, deposited, or stored on quays, wharfs, or premises, the Trust strongly advises Owners or Consignees of such goods to arrange insurance cover to have them watched whilst the goods remain there.

FUELS AND PETROLEUM PRODUCTS

Vessels who do not have an account with Chrystal Petroleum, who require fuel from the tank should contact the Harbour Master.

Fuel agents are permitted to sell fuel across the quayside, however, in these circumstances, the following regulations will apply;

1. Any company, agency or individual wishing to use Eyemouth Harbour Trust quays for the transfer of petroleum products to and from vessels must first apply and obtain written permission from the Trust. Any company, agency or individual not obtaining written permission will not be allowed to undertake any transfer of petroleum products.
2. All approved agencies supplying Fuel and other Oils must account monthly to Eyemouth Harbour Trust for the total amount of oils, which have been exported or sold across the quay.
3. Failure to comply with the above will result in the consent being withdrawn.
